# CONTRIBUTORS

**Anastasiya Astapova** is a research fellow in Folklore in the University of Tartu. She defended two PhDs and published over 30 peer-reviewed works on migration, nationalism and humour. She is co-editor of the book *Conspiracy Theories in Eastern Europe: Trends and Tropes* (Routledge, forthcoming).

**Stef Aupers** is a cultural sociologist and works as professor of Media Culture at the Institute for Media Studies, department of Communication Sciences, Leuven University. He has published widely on media culture, online game culture and conspiracy culture in international, peer-reviewed journals.

**Kiril Avramov** is a post-doctoral research fellow of the Intelligence Studies Project (I.S.P.) at the University of Texas, Austin. Dr Avramov's main research interests are information warfare, psychological operations and mass cognitive hacking, as well as the 'weaponisation of information' and its respective application and effects on decision-making processes.

**Adrian Bangerter** is professor of Work Psychology at the University of Neuchâtel. His areas of research are social interactions at work, especially personnel selection; multimodal coordination in joint actions; and social transmission of beliefs, including the role of media in public understanding of science and the spread of conspiracy theories.

**David Barron** is a reader and deputy director at the Centre for Psychological Medicine at Perdana University. His work is primarily focused on the measurement and outcomes of schizotypy, particularly in different cultural settings.

**Eiríkur Bergmann** is professor of Politics at Bifrost University, Iceland. He writes mainly on nationalism, populism, European integration, Icelandic politics and participatory democracy. He is also a novelist.

**Mikey Biddlestone** is an associate lecturer and PhD student in Political Psychology at the University of Kent. He investigates the social identity motivations and group processes involved in conspiracy beliefs. Notable topics of interest include motivations, values and intergroup



stereotypes. He has contributed to the 2019 interim report on the 2011 riots in South London.

**Michał Bilewicz** is a professor at the Faculty of Psychology, University of Warsaw and a director of the Center for Research on Prejudice at the same institution. He is interested in social psychology of intergroup relations, dehumanisation and infrahumanisation processes, contact hypothesis and prejudice reduction, as well as linguistic aspects of discrimination.

**Nebojša Blanuša** is associate professor of Political Psychology at the University of Zagreb. His main research interests are the symptoms of the political unconscious and cultural trauma. He wrote the book *Conspiracy Theories and Croatian Political Reality 1980–2007* (Zagreb: Plejada, 2011; in Croatian) and co-edited the volume *EU, Europe Unfinished: Mediating Europe and the Balkans in a Time of Crisis* (Rowman & Littlefield, 2016).

**Michael Butter** is professor of American Studies at the University of Tübingen. He is the author of *Plots Designs, and Schemes: American Conspiracy Theories from the Puritans to the Present* (de Gruyter, 2014) and *The Nature of Conspiracy Theories* (Polity, 2020). Together with Peter Knight, he directed the C.O.S.T. Action C.O.M.P.A.C.T. [Comparative Analysis of Conspiracy Theories].

**Ben Carver** teaches Anglophone Literature and Culture at Aarhus University, Denmark. He is the author of *Alternate Histories and Nineteenth-Century Literature* (Palgrave, 2017) and is currently working on a project on the relation of detail to suspicion. Other interests include invasion fiction, the circulation of money in novels and the literature imagination of progress.

**Ute Caumanns** is a lecturer in the Department of History and Cultures in Eastern Europe at the Heinrich-Heine-Universität Düsseldorf, Germany. She teaches modern and contemporary Central-East European history. Her current research interests lie in visual and oral representations of conspiracy theories, especially in media aspects of Stalinist show trials.

**Aleksandra Cichocka** is a senior lecturer in Political Psychology at the University of Kent. Her research interests include intergroup relations, political ideologies and political engagement. She examines the intergroup dimensions of conspiracy theories and the ways self- and group-evaluations are associated with conspiracy beliefs. She co-edited *The Psychology of Conspiracy* (Routledge, 2015).

**Dana Crăciun** is a senior lecturer in the Department of Modern Languages and Literatures at the University of Timișoara. She teaches courses in Literary Studies, Creative Writing and Translation Studies. Her research interests include contemporary literature and theory, conspiracy narratives, and the theory and practice of translation.

**Sylvain Delouvée** is associate professor (H.D.R.) in Social Psychology in Rennes 2 University. His research topics are focused on collective beliefs and social thought. He is particularly interested in behaviours and conduct known as irrational through conspiracy theories and rumours, collective memory and social representations, collective fears and social identity.

**Karen M. Douglas** is professor of Social Psychology at the University of Kent. Her research focuses on why people believe in conspiracy theories, and what the consequences of these beliefs are for individuals, groups and society.

**Hugo Drochon** is assistant professor in Political Theory at the University of Nottingham and author of *Nietzsche's Great Politics* (Princeton U.P., 2016). **Asbjørn Dyrendal** is a professor at the Department of Philosophy and Religious Studies, Norwegian University of Science and Technology. His research centres on contemporary religion, mostly new religious movements, and conspiracy culture. Among his recent books are *The Invention of Satanism* (Brill, 2016), *Handbook of Conspiracy Theory and Contemporary Religion* (Brill, 2018) and *Hva er konspirasjonsteorier* (Universitetsforlaget, 2019).

**Vasily Gatov** is a Russian media researcher and author with more than 28 years of professional experience in domestic and international media such as on the Chernobyl nuclear disaster, the 1991 failed coup d'état, Boris Yeltsin's presidency and the first Chechen war (1994–1997). He later served as an executive and strategist for several Russian media companies.

**Pascal Girard** is Associate Research Fellow in Political History at the CRULH, University of Lorraine, Nancy–Metz (France). The subject of his PhD was conspiracies in France and Italy from 1944 to 1958. He is particularly interested in conspiracy theories and political violence and the dynamics at work between these two phenomena.

**Julien Giry** is a French political scientist and sociologist, and currently a research fellow at the University of Rennes. Since 2009, he has worked on conspiracy theories and far-right activism. He has published more than 20 articles and regularly appears in the media.

**Biljana Gjoneska** is a research associate at the Macedonian Academy of Sciences and Arts. **Estrella Gualda Caballero** is professor of Sociology at the Universidad de Huelva, Spain, where she is the Director of the Social Studies and Social Intervention Research Centre. She is President of the Andalusian Sociological Association and is currently working on social networks and social big data in connection to conspiracy theories.

**Doğan Gürpınar** is an associate professor at İ.T.Ü. He has published three books in English: *Ottoman Imperial Diplomacy* (I.B. Tauris, 2013), *Ottoman/Turkish Visions of the Nation: 1860–1950* (Palgrave Macmillan, 2013) and *Conspiracy Nation: Conspiracy Theories in Turkey* (Routledge, 2019). He has published articles on Turkish intellectual history, Turkish nationalism and historiography.

**Jaron Harambam** is an interdisciplinary qualitative sociologist working on conspiracy theories in today's technologically mediated information ecosystem. His PhD is from Erasmus University, Rotterdam. He held a postdoctoral research position (University of Amsterdam), and is now a

**Todor Hristov** teaches Literary Theory, Critical Theory and Biopolitics at the University of Sofia. **Roland Imhoff** received his PhD from the University of Bonn, Germany in 2010. He is currently Professor for Social and Legal Psychology at the Johannes Gutenberg University, Mainz, Germany. Together with Michael Butter, he directed the C.O.S.T. Action C.O.M.P.A.C.T. [Comparative Analysis of Conspiracy Theories].

**Péter Krekó** is a social psychologist and political scientist. He is a senior lecturer at the Social Psychology Department, E.L.T.E. University, Budapest, Hungary and a non-resident associate fellow at Johns Hopkins University S.A.I.S. Bologna Institute of Policy Research. During 2016–2017, he worked as a Fulbright Visiting Professor at Indiana University.

**André Krouwel** is an associate professor of Political Science and Political Communication at the Vrije Universiteit, Amsterdam. His research focuses on political parties, party systems, populism, voting behaviour, public opinion, extremism, belief in conspiracies, online polling, Big N data and Vote Advice Applications.

**Pia Lamberty** is a social psychologist and working on her PhD at the Johannes Gutenberg University, Mainz. In her research, she focuses mainly on the psychological aspects of conspiracy theories and their impact on society.

**Anthony Lantian** is an associate professor at the Université Paris Nanterre. His research interests lie in the origins, functional roles and social consequences of beliefs that people hold about the world, such as belief in conspiracy theories or belief in free will.

**Hugo Leal** is a research associate at the Centre for Research in the Arts, Social Sciences and Humanities (C.R.A.S.S.H.), University of Cambridge. As a research associate in the Institute for Political Studies and consultant in Ipsos Serbia, she leads numerous projects. She is interested in science scepticism, conspiracy theories, gender and collective action.

**Türkay Salim Nefes** is a William Golding Junior research fellow at Brasenose College, University of Oxford. He is the author of *Online Anti-Semitism in Turkey* (Palgrave, 2015) and various articles in journals such as the *British Journal of Sociology* and *International Sociology*.

**Kenzo Nera** is pursuing a doctorate in Social Psychology at the Université Libre de Bruxelles, Belgium. He works on the collective underpinnings of conspiracy theories.

He teaches intellectual history and political theory across various faculties. **Hulda Thórisdóttir** is an associate professor at the University of Iceland. Her broad interest is political ideology, its structure, causes and consequences. She has written on the role of fear in ideology, psychology of the 2008 economic crisis, political polarisation and voter turnout.

**Pranvera Tika** is a PhD candidate and a research fellow at the Centre of Political Research at Panteion University, Athens. Her main research interests focus on processes of democratisation of the Balkan countries, populist radical right parties in Europe, Holocaust remembrance, antisemitism and aggressive nationalism.
